#### 1. General Provisions

- 1.1. This document is an official offer (hereinafter referred to as the 'Offer') by the Legal Entity "Kazakhstan National Association of Professional Engineers and Consultants" (hereinafter referred to as the 'Organizer'), to any legal or natural person (hereinafter referred to as the 'Participant') to enter into an agreement to participate in the Caucasus and Central Asia Construction Forum (hereinafter the "Forum") under the terms set forth below.
- 1.2. By making payment, the Participant fully and unconditionally accepts the terms of this Offer, thereby concluding the Agreement.
- 1.3. The Offer is valid from the moment of publication on the Organizer's official resources (including https://knapec.kz) until the start date of the Forum.

## 2. Subject of the Agreement

2.1. The Organizer undertakes to provide the Participant with the opportunity to participate in the Caucasus and Central Asia Construction Forum held on June 9–10, 2025, in Astana at the address: Sheraton Astana Hotel, 60/1 Syganak St., and the Participant undertakes to pay for participation in accordance with the selected participation package.

## 3. Participation Terms and Payment Procedure

- 3.1. Participation in the Forum is carried out according to the packages provided, described on the official website and in the Organizer's information materials.
- 3.2. Payment is made via bank transfer to the Organizer's account.
- 3.3. All expenses related to travel, accommodation, and meals are covered by the Participant.

### 4. Rights and Obligations of the Parties

The Organizer shall:

- 4.1.1. Ensure the Forum is held on the agreed dates;
- 4.1.2. Provide the Participant with access to the event in accordance with the selected package;
- 4.1.3. Issue a certificate of participation if necessary.

The Participant shall:

- 4.2.1. Pay for participation in a timely manner;
- 4.2.2. Adhere to the code of conduct at the event;
- 4.2.3. Not violate the intellectual and property rights of third parties.

The Participant has the right to:

- 4.3.1. Participate in all activities provided by the program;
- 4.3.2. Receive consultation on the event agenda.

### 5. Liability of the Parties

- 5.1. In case of violation of this agreement, the parties bear responsibility in accordance with the legislation of the Republic of Kazakhstan.
- 5.2. The Organizer is not responsible for the Participant's inability to attend due to reasons beyond the Organizer's control.
- 5.3. In case the event is canceled by the Organizer, a full refund will be issued.

## 6. Refund Policy

- 6.1. Refunds are allowed within 14 (fourteen) calendar days from the date of purchase in accordance with the Law of the Republic of Kazakhstan on Consumer Rights Protection.
- 6.2. Refunds are made upon the Participant's written request stating the reason and providing proof of payment.

### 7. Personal Data Processing

- 7.1. The Participant consents to the processing of their personal data for the purposes of executing this agreement and for receiving information about future events.
- 7.2. Personal data will not be shared with third parties, except as provided by law.

### 8. Force Majeure

8.1. The parties are released from liability for partial or complete failure to fulfill obligations due to force majeure events (natural disasters, emergencies, etc.), provided

there is official confirmation.

9. Validity of the Agreement

9.1. This agreement becomes effective upon acceptance of the Offer and remains in force

until all obligations are fulfilled.

9.2. All disputes arising from this agreement shall be resolved through negotiations or in

court at the location of the Organizer.
